

### **Word on the Street Promotion Terms and Conditions**

Selection and Notification Process</b>	<p><b>Minor Prize Winner Selection</b></p> <ul style="list-style-type: none"><li>• Each Friday of the Promotional Period, the Promoter will select the Entry of the week that best reflects the theme of the competition and the potential for on air interest (<b>Judging Criteria</b>);</li><li>• The Entrant who submitted the Entry selected against the Judging Criteria will be the winner of the Minor Prize for that week (<b>Minor Prize Winner</b>).</li><li>• All Minor Prize Winners will be announced on air on 6PR at the end of each week of the Promotion and contacted via phone using the details provided to the Promoter at the time of entry.</li></ul>
