

### \$1,000 Minute Promotion Terms and Conditions

By entering into the draw to win the Prize, you (**Entrant**) acknowledge and accept the following terms and conditions, as well as the radio station's general conditions of entry, as amended from time to time.

<b>3. Promotional Period</b>	Open Date: 17 January 2022 at 5:30am Perth time Close Date: 02 December 2022 at 8:30am Perth time
<b>4. Entry Restrictions</b>	Entrants must be: <ul style="list-style-type: none"><li>• at least 18 years of age;</li><li>• residents of Western Australia</li></ul> Entrants must not be the employees (or their immediate family members) of: <ul style="list-style-type: none"><li>• The Promoter and its related bodies corporate; <input type="checkbox"/> The Prize Provider and its related bodies corporate; or <input type="checkbox"/> Any Agency associated with this Promotion.</li></ul>
<b>5. Entry/Contest Procedure</b>	To be entered into Promotion, Entrants must, during the Promotional Period: <ol style="list-style-type: none"><li>1. Listen to Radio 6PR Perth 882 during the Breakfast program between the hours of 5:30am and 8:00am Perth time ;</li><li>2. Each day, the program presenter (<b>Presenter</b>) will solicit Entrants for the Promotion by inviting listeners to call 133 882 (<b>Cue to Call</b>) to be given opportunity to answer 10 pre-selected general knowledge questions in 60 seconds (<b>Contest</b>) ;</li><li>3. After hearing the Cue to Call, calling the correct phone number and being successfully connected to an operator, one (1) Entrant will then be put through to air and invited to take part in the Contest (<b>Contestant</b>);</li><li>4. The Presenter will determine, in his or her absolute discretion, whether the Contestant has answered a question correctly ; and</li><li>5. If the Contestant answers one (1) or more questions correctly they will receive \$10 AUD for each question they answer correctly (<b>Winner</b>) unless the Contestant answers all 10 questions correctly, in which case they will receive a total prize of \$1,000 AUD (<b>Major Winner</b>).</li></ol> If the Contestant does not answer any questions correctly they will not be entitled to any prize or cash payment. - c) Throughout the Promotional Period the Promoter may contact Entrants to interact with the station on air, online and via social media in relation to the Promotion.
- d) The Promoter will not disclose personal information to any entity outside of Australia.
- e) Entrants may be required by the Promoter and Prize Provider to participate in photo, recording, video and/or film session(s) and acknowledge that they assign, by way of present assignment of future copyright, the right to use such publicity materials in any medium (including, without limitation, the internet) and in any reasonable manner it sees fit.
- f) It is a condition of Entry that the Promoter and Prize Provider have the right to publicise, broadcast and communicate to the public the names, characters, likenesses or voices of Entrants for any promotion or matter incidental to the Promotion. If a Prize is unavailable for any reason, the Promoter, at its discretion, may substitute it for another item of equal or higher value. The Prize is subject to any Prize Restrictions specified above. All Prize values stated are the recommended retail value as provided by the supplier, are in Australian dollars and are correct at the time of preparation of these terms and conditions.
- p) All Prizes and parts of the Prize are subject to availability, non-transferable and non-exchangeable, must be used on or by all dates specified in these terms and conditions and as stipulated by the Prize Provider and are not redeemable for cash unless cash is specified.
- q) Unless otherwise stipulated in this agreement, if the Prize must be used on a specific date (Expiry), and the Winner is unable to use it on that date, the Winner will forfeit the Prize and the Promoter may select a new winner in its absolute discretion on or before Expiry.
