

Word on the Street Promotion Terms and Conditions

Selection and Notification Process	Contributor(s) of the Week <u>Selection Process</u> To be nominated as a weekly 'Word on the Street' contributor (Contributor of the Week) by the 6PR Drive Program, during the specified dates during the promotional period, the Contributors of the Week will be determined by the following process: <ul style="list-style-type: none">Each Friday of the Promotional Period, the Promoter will select the Entry of the week (Weekly Winner) that best reflects the theme of the competition and the potential for on air interest (Judging Criteria);The Promoter, in its absolute discretion, may select an additional Entrant (in addition to the Weekly Winner), based on the Judging Criteria, to be declared additional Contributors of the Week (Wildcard Entry).Each Contributor of the Week and Wildcard Entry will go into the Draw to win the Major Prize (Prize Draw), provided that they provide the Promoter with the required personal details, including a valid email address. <u>Notification of Contributors of the Week:</u> <ul style="list-style-type: none">All Contributors of the Week will be announced on air each Friday on the 6PR Drive Program and go into the Prize Draw.All Contributors of the Week will be contacted by email using the email address provided at the time of entry. The decision of the Promoter in selecting the Contributors of the Week is final and no correspondence will be entered into.

Major Prize Draw Process	Major Prize Draw Process: <ul style="list-style-type: none">The Major Prize Draw will take place at the Major Prize Draw Location on the Major Prize Draw Time and Date;Each Contributor of the Week will be allocated a number;Starting from 3:00pm, the Promoter, or a person nominated by the Promoter, will then select one numbered ball at random from the barrel until there is only one ball left;The Contributor of the Week whose number corresponds to the number of the final ball is declared the winner (Winner);All Minor Prize Winners and Wildcard Entrants must be present, in person at the Prize Draw Location on the Prize Draw Date at the Prize Draw Time to claim the Prize. If Entrants are unable to be present, they may nominate a proxy. The promoter must be notified of a proxy no less than one (1) week out from the major draw date.
